Their valuable executive suggestions and advices are our executive regulations.

Regulations for Parents

- 1) Students must be regular, punctual and should report to school on prescribed scheduled.
- 2) Attendance in school is mandatory for every enrolled students. Any absence must be supported by a valid medical certificate, which shall be verify by school's attendance Committee.
- 3) If a student receiving free education remains absent for more than six days in a month, the monthly contribution will have to be paid.
- 4) Continuous absence for 15 days without prior leave will result in removal of the student's name from the school enrolment register.
- 5) Students must come to school in proper, clean school uniform and must wear their identity card. Carrying an extra uniform is permitted if required.
- 6) Hair must be kept neat and tidy at all times. Students must maintain proper personal hygiene.
- 7) Parents are expected to encourage their children to speak in English.
- 8) Parents must check the child's diary regularly and pay attention to any remarks given by the teacher.
- 9) Parents' contact numbers will be added to the school WhatsApp group. 10) Parents must stay updated through this group.
- 10) If parents have any suggestions or appeals, they may meet the teacher or the administrative office after 1:00 PM on Wednesdays and Saturdays.
- 11) Students must attend all compulsory school celebration days, such as:
Independence Day (15th August)
Gandhi Jayanti (2nd October)
Republic Day (26th January)
- 12) Private tuition is strictly not allowed.
- 13) Students enrolled for promotional classes will be taught only by the concerned teachers. The contribution amount for promotional studies will be the same as prescribed.
- 14) If a student damages any book belonging to the book bank, a fine of ₹20 will be charged. If a book is lost, the student will have to pay double the price of the book.

- 15) Students must purchase all stationery and writing materials from the school book bank only.
- 16) If a student loses or damages school-issued items, the following Fines will apply, contribution charge will be applicable.

Mandatory Rules for Contribution Card

- 1) Parents must pay the monthly contribution for their ward on or before the 10th of every month. This rule must be followed by all students, regardless of leave or absence.
- 2) A late fine of ₹50 will be charged if the contribution is paid after the 10th of the month.
- 3) The contribution will be accepted only on presentation of a valid contribution card.
- 4) The contribution is mandatory for the entire academic session, covering all twelve calendar months.
- 5) The examination-related contribution must be paid in three instalments during the academic year, strictly on the specified due dates.
- 6) A fine of ₹50 will be charged for issuing a duplicate contribution card in case of loss or non-submission. If the monthly contribution is not paid for two consecutive months, the student's admission will be cancelled.
- 7) The student's name will be struck off the rolls on the last working day of the month without prior notice. The student will not be allowed to attend classes or appear for unit, term, or final examinations.
- 8) The school will not be responsible for any consequences arising from such negligence.
- 9) If the 10th of the month is a school holiday, the contribution may be paid on the next working day without any late fine.
- 10) The contribution for the months of May and June must be paid by 10th May.
- 11) The contribution for the months of February and March must be paid by 10th May.
- 12) A student will be readmitted only after payment of all arrears along with a re-admission contribution amount of ₹510 as per school rules.
- 13) 50% of the admission contribution will be refunded only if an application for withdrawal is submitted within 7 days from the date of admission.
